1. Call to Order.

Mr. Jose Graveley, Board President, called the Regular Meeting of the STWA Board of Directors to order at 5:30 p.m. at the Courthouse Annex Law Enforcement Center, 1500 E. King, Kingsville, Texas. A quorum was present.

2. Citizen Comments.

Mr. Graveley opened the floor to citizen's comments. Mr. Drew Molly, Corpus Christi Water Chief Operating Officer, introduced himself, Esteban Ramos and Maria Corona and stated that the city is trying to work with the community and regional water partners. He recognized that water supplies are dwindling and the city is looking forward to being a part of the solution.

Kleberg County Judge Rudy Madrid thanked the STWA Board and stated that the work STWA is doing lines up with Kleberg County's plans. He stated that industry is looking to expand to this area and expressed the need to look at alternative water sources for industry.

The order of the agenda was changed to accommodate the guests.

6. <u>Discussion of Alternative Water Sources.</u>

Mr. Marez reported that at this point, the Board has been presented several options on alternative sources of water and added that Mr. Greg Szuman of Willatt & Flickinger was present by Zoom to discuss the matter with the Board. Mr. Rogelio Rodriguez, Water Finance Exchange, noted that providing an additional water source can be funded by the state and he would like to target December 2024 for a decision from the Board on what to request from the state.

Mr. Graveley announced that the Board would convene in Closed Session at 5:39 p.m. pursuant to Section 551.071 of the Government Code to discuss water sources and the City of Corpus Christi Water Supply Contract with the Authority's attorney. The Board reconvened in Open Session at 6:18 p.m. No action was taken during Closed Session.

Mr. Galvan made a motion to authorize Mr. Marez and management to engage in a water study on behalf of South Texas Water Authority. Mr. Rodriguez seconded. All voted in favor.

Mr. Sendejo presented the O&M Report and CP Update. He stated that he is in the process of filling the foreman position and has scheduled training and testing for some members of the field staff. There were no questions from the Board.

7. Authorization to purchase replacement pump for Central Pump Station to feed spurline.

Ms. Wagner presented quotes for a replacement pump for the Central Pump Station. She explained that the entire assembly needs replacing and the pump is needed as soon as possible since it is the lead pump and provides pressure to the west service area including Agua Dulce, Sablatura Park and Banquete Pump Stations. Odessa Pumps (DNOW Process Solutions) provided a quote of \$8,710 with delivery in 14-15 weeks. PS Inc. provided a quote of \$6,409 for the pump only without the entire setup. Smith Pump Company, Inc. provided a quote of \$14,979.69 with a lead time of 4-5 weeks and a 12-month warranty. This option includes the complete setup. Mr. Galvan made a motion to authorize purchase of the replacement pump from Smith Pump Company in the amount of \$14,979.69. Mr. Rodriguez seconded and the motion passed unanimously.

- 8. Petition for Addition of Certain Lands to the South Texas Water Authority and setting of public hearing date, time and place.
 - Isaac Lee Felan 1.31 acres, more or less, situated in the Casa Blanca Survey, Being Lot 16-H, The Ranch, an unrecorded subdivision, Nueces County, Texas

The Board reviewed the Annexation Petition. The property owner recently approached the Nueces Water Supply Corporation requesting service outside of the Authority's district boundaries and filed an Annexation Petition to begin the process of obtaining water service on the property. Mr. Marez recommended approval of Resolution 24-08 setting the Public Hearing on May 21, 2024 at 5:30 p.m. at the STWA conference room.

9. Resolution 24-08. Resolution of determination of validity of Petition for Addition of Certain Lands to the South Texas Water Authority and setting the date, time and place for a public hearing and authorizing publication of public hearing notice. (Isaac Lee Felan).

Ms. Lowman made a motion to adopt Resolutions 24-08 setting the Public Hearing on May 21, 2024 at 5:30 p.m. at the STWA conference room and authorizing publication of the public hearing notice. The motion was seconded by Mr. Rodriguez and passed unanimously.

10. Presentation by Triton Energy Services: Project Nobel.

Mr. Robert Mathis of Triton Energy Services stated that he has been working hand in hand with water leaders in the Permian Basin area on a 42-inch waterline project that includes right of way and easements across 480 miles. The company is also in discussions with other interested parties. He stated that he wanted to introduce the project to the Board and will return to visit and provide more in-depth information at a later time.

11. Administration Report.

Mr. Marez thanked the Board for the investment in personnel in the Finance Department. With the Accountant Assistant on maternity leave, the new intern has stepped in and been helpful in carrying out the necessary work.

He also reported that the City of Corpus Christi is now in Stage 2 of their Drought Contingency Plan and expects to move to Stage 3 sometime in the summer.

12. Adjournment.

With no further business to discuss, Ms. Garza moved to adjourn the meeting at 6:54 p.m. Mr. Rodriguez seconded. The motion carried.

Re: CP Department

Since January 15, 2024 some changes have been made to our CP Pipe to soil and rectifier readings from weekly to Bi – monthly, and pipe to soil surveys to Quarterly.

This will let CP spend more time on testing for high resistance areas and repair if needed, and allow time to work on ARVs that need atmospheric attention.

CP Dept will also have more time to help with one call work.

We have installed two ground beds, one on contract 1 and another on contract 3 at CR. 36 in Robstown.

NEC is scheduled to install Electric service on June 11 2024, at Rectifier #4 at CR. 36 which will provide CP protection to Contract 3.

We are planning to install the #3 ground bed and rectifier at CR. 28 at the Tesla facility by the end of May and first part of June.

The fourth and final Rectifier #2 will be installed around June or July. I am waiting on farmers and landowners to harvest cotton as to not cause problems for the future as agreed by tenant and landowner.

Our main line is definitely going in the right direction with the impressed current.

I have attached a survey to compare progress from 2023 vs 2024.

The graphs numbers will show how we are going in more negative direction.

Topic: Alternate Water Source Options

Background:

With our on-going efforts to explore potential water source options for the STWA the item is available for discussion with staff or legal team. During our last meeting several groups were represented including the first of its kind produced water company (Triton Energy Services), the City of Corpus Christi Water Department (CCW), brackish water and ground water interests.

Analysis:

As water becomes scarcer and more competitive to secure water rights the South Texas Water Authority must pursue all options available within our service area and beyond.

Available for review are the options of: Surface Water, Groundwater, Brackish Water, Water Reclamation, **Produced Water and Other Emerging Water Options.**

Staff Recommendation:

Provide staff guidance on formal water source proposals.

Board Action:

Review water options and direct staff to seek out future STWA water sources and contracts.

Summary:

Finding the right water source is a complex process, requiring thorough research and evaluation by the STWA Management and our expert team of engineers and financial advisors. The board plays a crucial role in making this decision. Your input, including support, questions, and concerns about the available water sources in our region, is vital for selecting the best future options.

Analysis:

The annexation petition and property described is owned by Isaac Lee Felan and seeks entry into the STWA's district boundary. This is similar request to previous petitioners that the Board has approved admittance into the STWA area and as a NWSC retail customer.

In accordance with Section 26.01(e) of the Texas Property Tax Code, I am enclosing the 2024 Certified Estimate of Taxable Value for your taxing entity. The 81st Texas Legislature changed the deadline for the Chief Appraiser to prepare and certify estimates of taxable value to the assessor for each taxing unit by April 30th of each year or the next business day if the 30th falls on a weekend (Section 1.06 of the Texas Property Tax Code). This makes a significant difference in the benefit that these values present to you at this point in time for the purpose that you are intending to use them for. Please remember the majority of the exemption application deadlines are April 30, 2024, the majority of special appraisal applications deadlines are April 30, 2024, rendition extensions are through May 15, 2024, and some may be through June 1, 2024. All these issues play a part in a less accurate estimate of value. Other potential loss may occur due to allowable late filing of exemptions and due to additional information provided to the appraisal district by the taxpayer addressing specific issues with their property before the final roll is approved. I will be providing you with another set of estimated values no later than June 30, 2024, so that you will be given the ability to work with some updated information.

Topic: Ratification of Proposal from ICE for Water Sources Feasibility Study

Background:

The issue of seeking out viable water sources in our service area has been an on-going point of discussion for both board and staff. During our April 23rd meeting the Board of Directors provided a motion for International Consulting Engineers (ICE) to conduct a water feasibility study. ICE has submitted a proposal for the execution of a Groundwater Sources Feasibility Study to determine potential locations for water wells within the STWA Service Area. The proposed scope of work includes coordinating with STWA, engaging with state and federal entities for permitting requirements, collecting and reviewing relevant data, and preparing a comprehensive written report to prepare for next steps in our search of available water.

Analysis:

The proposed scope of work aligns with the STWA's objectives of exploring groundwater sources to supplement our existing water supply. ICE's expertise in hydrogeology and aquifer evaluation positions them well for this project. The feasibility study will provide valuable insights into the viability of constructing water supply wells and the potential groundwater quality in the STWA Service Area.

Staff Recommendation:

Based on the analysis of ICE's proposal, staff recommends proceeding with the Groundwater Sources Feasibility Study as outlined by ICE. The proposed scope of work is comprehensive and addresses the key objectives of the project. ICE's fee of \$117,184.00 for the professional services is reasonable considering the level of effort and duration of the project.

Board Action:

Review and determine to ratify previous board motion which now has a measurable scope of work, cost and timeframe for this project.

Summary:

In summary, ICE's proposal offers a sound approach to conducting a Groundwater Sources Feasibility Study for the STWA Service Area.
