#### 1. Call to Order.

Mr. Jose Graveley, Board President, called the Regular Meeting of the STWA Board of Directors to order at 5:30 p.m. at the Courthouse Annex Law Enforcement Center, 1500 E. King, Kingsville, Texas. A quorum was present.

#### 2. <u>Citizen Comments.</u>

Mr. Graveley opened the floor to citizen's comments. Mr. Andrew Mendez commented that STWA has lost control of its own water contract and documents need to go through lawyers. He added that STWA is trying to sell water and buy water using the same pipeline. He added that he has learned more about STWA from the Corpus Christi meetings than locally and questioned the Authority's transparency. He asked for clarity, accountability, and leadership and said he will continue to monitor the project in order to inform the public.

#### 3. Approval of Minutes

Mr. Rodriguez made a motion to approve the minutes of the September 3, 2025 Special Meeting, the September 9, 2025 Public Hearing and the September 9, 2025 Regular Meeting as presented. Ms. Garcia seconded. The motion passed by unanimous vote.

Mr. D. Morales made a motion to approve the Treasurer's Report and payment of the bills as presented. Ms. Garza seconded. The motion passed unanimously.

#### 5. Operation and Maintenance Report.

Mr. Sendejo reported that work continues on corporation tasks. He added that staff training is ongoing but a Field Technician recently resigned.

#### 6. Fiscal Year 2025 Budget Amendments.

Mr. Patroelj reviewed the amended budget. Total Revenues increased by \$563,812 and Total Expenditures decreased by \$173,708 for a decrease of \$387,104 in Net Income ending at -\$74,555. Mr. D. Morales made a motion to approve the final amended FY 2025 budget. Mr. Rodriguez seconded and all voted in favor.

# 7. <u>Tax year 2025 tax roll/levy for the South Texas Water Authority's district in Kleberg County.</u>

The Board reviewed the Kleberg County tax roll/levy for Tax Year 2025 reflecting a taxable value of \$1,819,835,627.

8. Resolution 25-28. Resolution adopting the tax roll/levy for the South Texas Water Authority's district in Kleberg County for tax year 2025.

Mr. D. Morales made a motion to approve Resolution 25-28 adopting the tax roll/levy for South Texas Water Authority's district in Kleberg County for tax year 2025. Ms. Garcia seconded the motion and all voted in favor.

9. <u>Tax year 2025 tax roll/levy for the South Texas Water Authority's district in Nueces County.</u>

The 2025 Nueces County tax roll has not been completed and will be presented at the next meeting.

10. Resolution 25-29. Resolution adopting the tax roll/levy for the South Texas Water Authority's district in Nueces County for tax year 2025.

The Board tabled Resolution 25-29.

Mr. Marez informed the Board that their review and approval of STWA's Investment Policies is required every year and added that there have been no changes to the Policies since last year. He recommended adoption of Resolutions 25-30, 25-31 and 25-32 approving the STWA General Fund, Debt Service Fund and Capital Project Fund Investment Policies.

- 12. Resolutions 25-30 through 25-32. Resolutions approving the following South Texas Water Authority Investment Policies:

  - b) South Texas Water Authority Debt Service Fund
  - c) South Texas Water Authority Capital Projects Fund

Mr. Graveley made a motion to adopt Resolutions 25-30, 25-31 and 25-32. Ms. Garcia seconded. All voted in favor.

13. Extension of depository agreement with Prosperity Bank.

The Board reviewed a letter from Prosperity Bank for a two-year renewal of the Depository Contract between South Texas Water Authority and Prosperity Bank based on the current terms. Mr. D. Morales made a motion to accept the renewal of the Depository Services Contract with Prosperity Bank. Mr. Rodriguez seconded the motion and all voted in favor.

14. Mold remediation at STWA office building.

Tabled.

15. <u>Discussion and Action Proposed: Environmental Impact Study by Texas A&M University – Kingsville Engineering Department.</u>

Mr. Ivan Luna of International Consulting Engineers (I.C.E.) presented the updated proposal for a Groundwater and Brine Water Quality Evaluation for the Proposed Desalination Plant near Driscoll, Texas. The proposal from the Texas A&M University-Kingsville Engineering Department in the amount of \$21,999.66 is for a study to provide data on brackish groundwater and the expected brine composition for informed design and engineering of the desalination plant. Ms. Pena made a motion to approve the proposal, Ms. Garcia seconded and all voted in favor.

16. <u>Discussion and action to determine the need for an appointment of members for an audit</u> committee.

Ms. Wagner stated that after some recent questions from the Board, auditor Margaret Kelly recommended creating an audit committee made up of Board Members for review of the audit prior to presentation to the Board. Mr. Graveley made a motion to organize an audit committee and appoint Mr. J. Morales, Mr. D. Morales and Ms. Garza as members. The motion was seconded by Mr. Rodriguez and passed by unanimous vote.

17. Authorization to purchase brush cutter attachment with FY 2025 funds.

Mr. Marez presented a bid from Nueces Power Equipment for the purchase of a brush cutter attachment in the amount of \$10,540. He explained that funds are available in the FY 2025 budget. The equipment will allow for more effective clearing of heavy brush and vegetation enabling staff to complete maintenance activities in a timely and cost-efficient manner. Mr. D. Morales made a motion to authorize the purchase of a brush cutter using FY 2025 funds. Ms. Garza seconded and all voted in favor.

18. Water Supply Contract with the City or Corpus Christi.

Mr. Graveley announced that the Board would convene in Closed Session at 6:26 p.m. pursuant to Section 551.071 of the Government Code to receive legal advice from counsel regarding the water supply contract with the City of Corpus Christi and an alternate source of water for the Authority.

With no further business to discuss, Mr. Rodriguez moved to adjourn the meeting at 7:28 p.m. Mr. J. Morales seconded. The motion carried.

#### 1. <u>Call to Order.</u>

Mr. Jose Graveley, Board President, called the Special Meeting of the STWA Board of Directors to order at 12:00 p.m. at the South Texas Water Authority Boardroom, 2302 E. Sage Road, Kingsville, Texas. A quorum was present.

#### 2. Citizen Comments.

Mr. Graveley opened the floor to citizen's comments. Mr. Andrew Mendez, 405 E. Alice, Kingsville, Texas, representing South Texas Water Watch, commented that he has researched STWA's past meetings and reviewed the Board's actions and will continue to monitor and share information with the public. He questioned the Board's decision to enter into an agreement with Seven Seas and said he would continue to monitor the Board's actions.

#### 3. Payment of Bills.

Mr. J. Morales made a motion to approve payment of the bills as presented. Ms. Garza seconded. The motion passed unanimously.

#### 4. Request for Proposals: Condition Assessment – 42" Transmission Line.

Mr. Marez stated that an assessment of the Authority's 42" transmission line is necessary whether or not the Board decides to sell water to the City of Corpus Christi. He presented a Request for

Proposals developed by I.C.E for assessing the mechanical fittings on STWA's 42" waterline including 25 air release valves and five gate valves. He said he prefers to follow through with the RFP for transparency reasons and to open up the project for competitive bidding although legal counsel informed him that the RFP is not a requirement. Mr. Ivan Luna, I.C.E., explained that this is for an assessment of the appurtenances only and will be followed up by recommendations from their structural engineers. Mr. Marez added that he was recently notified that STWA qualified for additional state funding and is waiting for the formal award notification which will specify the amount of funding. This funding could be used towards the assessment and follow-up projects to address any infrastructure issues. Mr. J. Morales made a motion to authorize the Executive Director to issue an RFP for the 42-inch Transmission Line Mechanical Condition Assessment in accordance with Texas Local Government Code and Texas Water Code requirements and to return to the Board for contract award once proposals have been received and evaluated. Ms. Garza seconded. All voted in favor.

#### 5. Adjournment.

With no further business to discuss, Ms. Garza moved to adjourn the meeting at 12:15 p.m. Mr. Rodriguez seconded. The motion carried.



Re: Procurement Method for Mold Remediation Services – STWA Office

#### Background:

The South Texas Water Authority (STWA) office located at 2302 E. Sage Road, Kingsville, Texas, has been identified as requiring mold remediation services following an environmental assessment conducted earlier this year. Due to the age of the facility and potential health and safety impacts, it is essential that remediation be completed promptly using a procurement process that ensures compliance with Texas procurement laws while securing the most qualified and cost-effective contractor.

#### Analysis:

Under Texas Local Government Code Chapter 252 and Texas Water Code Chapter 49, local government entities such as STWA must follow formal purchasing procedures when procuring services exceeding \$50,000 in value. Mold remediation services fall under specialized environmental and building maintenance categories, where experience, technical qualifications, and safety protocols are essential evaluation criteria.

To ensure compliance and efficiency, the best procurement method for this type of work is through a Job Order Contract (JOC) using an approved cooperative purchasing program such as BuyBoard, TIPS-USA, or Texas SmartBuy. This approach provides several advantages:

- Pre-Qualified Vendors: Cooperative contracts include firms that have already met competitive bidding requirements and are qualified to perform environmental and remediation services.
- Reduced Administrative Burden: STWA can expedite procurement without issuing its own full
   Request for Proposal (RFP), saving time and administrative costs.
- Competitive Pricing: Contract pricing is pre-negotiated and benchmarked against market standards, ensuring cost effectiveness.
- Regulatory Compliance: Cooperative purchasing satisfies statutory requirements for competitive procurement under Texas law.
- Safety and Quality Assurance: Vendors under these programs must maintain required insurance, safety certifications, and compliance with OSHA and TCEQ standards.

The chosen contractor will be required to:

• Perform all remediation in accordance with Texas Department of Licensing and Regulation (TDLR) mold remediation rules;

• Provide a Mold Remediation Work Plan (MRWP) and Post-Remediation Verification Report (PRVR); and Coordinate with the Authority to minimize operational disruption during the remediation process.

### Staff Recommendation:

It is recommended that the Board authorize staff to procure mold remediation services for the STWA Office at 2302 E. Sage Road, Kingsville, Texas, through a cooperative purchasing agreement using a Job Order Contract (JOC) method, consistent with Texas procurement statutes and STWA purchasing policies.

#### **Board Action:**

Authorize the Executive Director to engage a qualified mold remediation contractor through a cooperative purchasing program such as BuyBoard, TIPS-USA, or Texas SmartBuy, and execute a Job Order Contract for the required work, subject to legal review and final cost verification.

#### Summary:

This procurement method ensures STWA remains compliant with state purchasing laws while addressing an urgent health and safety concern. The use of a cooperative Job Order Contract provides a timely, transparent, and cost-effective means of securing qualified remediation services for the Kingsville office facility.

# Background:

Texas Coalition for Affordable Power (TCAP) began purchasing electricity on behalf of the membership through a Strategic Hedging Program (SHP) in 2021 for a 5-year period. The program allows the energy consultants to purchase large amounts of energy 24 months in advance and take advantage of favorable market pricing. It has proven to be successful and has saved TCAP members from over paying on electricity especially during inflationary periods.

### Analysis:

The current SHP agreement that STWA signed will expire in 2026. TCAP Board of Directors voted to extend the SHP another 5 years and is allowing current TCAP members the opportunity to exit TCAP before December 31, 2025 without penalty. However, if STWA extends membership and decides to cancel prior to December 31, 2027 penalties will apply.

# **Staff Recommendation:**

As a member of the TCAP Board of Directors, I highly recommend STWA to remain a member of TCAP allowing the Authority to take advantage of the Strategic Hedging Program.

# **Board Action:**

Determine whether STWA should remain a member of TCAP. No action is necessary if STWA remains a member of TCAP.

# Summarization:

Staff has seen significant savings since becoming a member of STAP in 2001. STAP then merged with CAPP in 2011 to form TCAP. The professionals and consultants that are contracted by TCAP are extremely knowledgeable and work for the members of TCAP and not the "For Profit" corporations.

Thanks to the Board's forward-thinking approach, we've been purchasing energy 24+ months in advance to lock in the best rates and long-term stability for our members. Designed around member needs, SHP has proven to be the best combination of customer service, competitive price and flexibility to take advantage of favorable pricing available in the market.

In January 2026, we'll finalize the final year of our current 5-year procurement cycle, which runs through December 31, 2027.

At its most recent meeting, the TCAP Board voted unanimously to extend SHP for another five years covering Calendar Years 2028 through 2032. Procurement for that term will begin in February 2026. This extension ensures continued access to competitively priced power and the strategic benefits you've come to expect from TCAP.

Because your organization's Commercial Electricity Service Agreement (CESA) with GEXA runs through December 31, 2037, there's no need for a new contract to continue participating in SHP. That long-term structure was designed to ensure a smooth continuation — no paperwork, no hassle.

# Here's what you need to know:

- If you intend to remain a TCAP member, no action is required. You're all set!
- If you plan to exit TCAP, we'll need a written notice by December 31, 2025.
  - This will prevent us from including your load in the 2028–2032 energy procurements.
  - There are **no penalties** for leaving the SHP post-2027 if proper notice is given.
  - However, moving your electric accounts before 12/31/2027 will result in financial penalties due to the existing procurement commitments.

# TCAP Member,


I understand that many brokers are reaching out to your organization, and I have received numerous calls and emails from our members regarding this matter.

It appears that one of our competitors is being particularly assertive, sending targeted emails to our membership based on information obtained through open records requests. If you receive an open records request pertaining to your contract, please review it thoroughly and only provide the specific documents requested. Any letters or emails! have sent to the membership are not considered part of the contract. If you have any questions about open records requests, please contact me or our attorney, Thomas Brocato.

In response to the issues that this competitor accuses TCAP of, I would like to point out the following:

- TCAP proudly serves 172 local governments across Texas, making us one of the largest groups
  focused exclusively on local government needs. Engaging a broker who is a member of a cooperative
  buying group does not provide additional benefits. Cooperative contracts are not ideal for electricity
  procurement because rates fluctuate daily, and these contracts are based on a single point in time,
  unlike TCAP's regular market engagement. Brokers with primarily commercial clients and limited
  local government experience may not fully understand the unique requirements of local government
  operations.
- Rates provided by brokers are often outdated, as electricity prices can change daily. It's important to
  verify whether the rates offered in broker communications reflect current market conditions or are
  from previous years. Some brokers may exclude certain charges that have always been part of the
  energy price prior to Winter Storm Uri (2021) to make their rates appear lower. This exclusion is a
  marketing tactic, and it can result in unpredictable monthly charges for required ERCOT market
  items. In contrast, TCAP negotiates to lock in these costs, providing our members with greater budget
  stability.
- TCAP does NOT discourage our members from doing their due diligence. We offer support and
  resources, including an RFP sheet designed to help you ask the right questions—questions that
  brokers may prefer you didn't know to ask. By utilizing these tools, you can make informed
  comparisons and decisions.
- TCAP accesses the wholesale market each month, securing prices from investment-grade suppliers and ensuring that no single supplier contributes more than 30% to our portfolio. This approach guarantees diversity, with at least four suppliers represented annually. Our procurement program, developed with one of the largest investment-grade energy traders in the United States, fosters competition and ensures our members receive the best possible prices. Although brokers claim TCAP works with only one supplier (Gexa), this is inaccurate. By law, we must have a REP in the deregulated market, but our REP serves only as a billing agent for the power sourced from the

wholesale market. Our REP has nothing to do with our electricity pricing. Brokers operate exclusively in the retail market.



(The REP average includes all of the excluded line items)

- Electricity purchasing is not solely about the volume of kilowatts consumed, but rather the load
  factor. TCAP aggregates member usage, resulting in a load factor that exceeds the ERCOT average.
  Local governments typically use more power overnight than commercial businesses. This
  aggregation provides our members with superior buying power based on their load profiles, unlike
  individual contracts arranged through brokers.
- Energy markets are currently extremely volatile and prices are high. TCAP does not endorse long-term
  contracts as beneficial in these conditions. SHP, for example, only purchases one-year contracts.
  While extended contracts may secure profits for our competitors, they can prevent you from
  benefiting from favorable market changes in the future. The energy market is dynamic and is
  expected to evolve into a more buyer favorable position in the coming years.
- As part of our commitment, TCAP attorneys actively represent local governments at the Public Utility Commission (PUC) during TDU rate cases—something brokers are unable to do. Over the past decade, our participation has resulted in significant avoided costs for local governments:

Oncor: \$786,421,972 in avoided costs Centerpoint: \$2,948,557,747 in avoided costs

AEP: \$251,309,507 in avoided costs TNMP: \$123,350,622 in avoided costs

Additionally, TCAP introduced a bill in the 89th legislative session to exempt local governments from the gross receipts tax. Although the bill did not pass out of committee, TCAP remains dedicated to advocating for our members' interests in Austin—something brokers do not do.

After review, Caldwell Country Chevrolet's 2026 Silverado 4x2 Regular Cab is the lowest responsive bidder meeting specifications at \$34,989.00. Although the delivery time is longer (90–120 days), the cost savings are significant compared to other compliant bids. Sames Ford's 2025 F150 2WD Supercrew (\$41,963.00) represents the lowest Ford option and earliest availability; however, it exceeds the lowest compliant bid by \$6,974.

# **Staff Recommendation:**

Staff recommends awarding the bid Hacienda Ford for one (1) 2026 Ford F150 4X4 Super Crew Cab XL-145 at a total cost of \$44,679.75, which considers the responsible bidder meets the required specifications under Texas Local Government Code §252.043 and allows for a responsible price, delivery time and meets powertrain requirements for field operations.

### **Board Action:**

Authorize the Executive Director to issue a purchase order to Hacienda Ford for one (1) 2026 Ford F150 4X4 Super Crew Cab XL-145 at a total cost of \$44,679.75, and execute all related documents necessary to complete the purchase.

Re: Travel Policy and Expense Reimbursement Standards

# Background:

The South Texas Water Authority (STWA) periodically authorizes employee and board member travel to support the agency's mission, including attendance at professional development workshops, technical conferences, regulatory hearings, and legislative or interagency meetings. To ensure transparency, accountability, and consistency in travel-related reimbursements, it is necessary to establish a travel policy that aligns with both federal and state best practices while maintaining sensitivity to local cost conditions.

The General Services Administration (GSA) provides federal per diem guidelines widely recognized as the industry standard for travel reimbursement. However, since STWA operates within Texas and serves as a local governmental entity, it is appropriate that reimbursement rates correspond more closely to those used by the State of Texas for employee travel.

### Analysis:

The proposed travel policy incorporates guidance and best practices from the GSA and the Texas Comptroller of Public Accounts. The policy addresses eligible travel-related expenses and provides clear limits and documentation standards to support reimbursement for employees and key officials. (Key Officials consist of the Executive Director and members of the Board of Directors.

# • 1. Lodging

- Lodging costs shall not exceed the nightly rate established by the Texas Comptroller for the destination city. If no other lodging is available and it exceeds the nightly rate, reimbursement must be approved by the Executive Director or designee prior to authorizing approval for travel.
- Travelers are encouraged to secure the most cost-effective lodging consistent with safety and proximity to the meeting or conference venue.
- Itemized receipts are required for reimbursement.

# 2. Meals and Incidental Expenses (Per Diem)

 Meal reimbursements shall follow the State of Texas per diem schedule based on the travel destination.  Reimbursement will not exceed the maximum daily rate as published by the Texas Comptroller's Office.

# 3. Mileage

- Mileage reimbursement will follow the standard rate set by the Texas Comptroller, currently tied to the annually adjusted IRS business mileage rate.
- Travel shall be by the most direct and cost-effective route, and mileage logs must be maintained and submitted for reimbursement.

# 4. Rental Cars and Transportation

- Rental cars may be used when necessary and when more cost-effective than personal vehicle use, shuttle service, or other options.
- Only compact or midsize vehicles are authorized unless business needs require otherwise.
- Gasoline expenses for rental cars will be reimbursed with receipts.

### • 5. Airfare

- Airfare reimbursement will be limited to coach class or equivalent fare.
- Travelers are encouraged to book flights early to take advantage of lower rates.
- Additional charges (e.g., baggage fees) will be reimbursed with receipts if incurred for official business.

### • 6. Other Reimbursable Expenses

- Parking, tolls, and registration fees for conferences or workshops are reimbursable with receipts.
- Non-reimbursable expenses include entertainment, alcohol, personal items, and companion travel costs.

# 7. Documentation and Approval

- All travel must be pre-approved by the Executive Director or designee.
- A completed Travel Authorization Form and supporting documentation (agenda, invitation, or itinerary) must accompany reimbursement requests.
- Reimbursement will be issued upon submission of itemized receipts and completion of a travel expense report within ten (10) business days after returning.

# **Staff Recommendation:**

It is recommended that the Board of Directors approve the adoption of the STWA Travel and Expense Reimbursement Policy as presented, establishing consistency with GSA best practices while adopting rate standards used by the State of Texas for travel-related expenses.

# **Board Action:**

Authorize adoption of the South Texas Water Authority Travel and Expense Reimbursement Policy as presented and direct staff to implement and distribute the policy to all employees and board members.

# Summary:

This annually adjusted policy provides a clear and transparent framework for managing travel-related expenses. It ensures compliance with best practices, aligns with established public-sector standards, and reflects prudent fiscal management consistent with the Authority's responsibility to its wholesale customers and taxpayers.

**Subsistence Policy** 

Upon reviewing the Policy Manual for STWA I noticed that the current subsistence expense has been and I quote "\$25.00 per day." Now this might have been appropriate for such a time as then but that was thirty years ago. I have done some research and I have included such research for you to view. I have pulled data from the State Comptroller's office and data from the U.S. General Service Administration (GSA). Upon reviewing these two documents, I highly recommend that we modify our policy with the current rates provided in these documents respectively. I would recommend that these rates become effective 'immediately. Thank your prompt and courteous resolve to this matter:

- 5. Taxicab fares or automobile charges or automobile mileage from common carrier to place of abode and place of business and tips.
- 6. Taxicab fares, rental automobile charges or automobile mileage between place of lodging and place of business while in out-of-the-district travel status.
- 7. Fees for parking an automobile at a common carrier terminal or other parking area allowable to the extent that the fee plus the allowable mileage reimbursement to and from the destination does not exceed the estimated cost of using a taxicab.
- 8. Use of privately owned automobiles by employees, other than the Executive Director, shall be reimbursed on a mileage basis at the rate established by the Internal Revenue Service. Reimbursement of parking fees and tolls shall also be allowed.

The Executive Director may approve, after six months of employment, the full expense of attending seminars, conferences, conventions, or other educational institutions within the Southwestern states. Prior to such service, time off with pay may be permitted by the Executive Director if a staff member desires to attend a professional seminar, conference or convention at his own expense if it does not directly relate to job performance.

Employees in official travel status shall be entitled to transportation, accommodations and services which meet reasonable and adequate quality standards for convenience, safety, and comfort; tourist or business class accommodations are to be used, if available.

# C. Allowance of Actual Subsistence Expenses

Employees shall be granted actual subsistence expenses while in an out-of-the-district status. The employee shall be reimbursed for actual subsistence expenses only. Actual subsistence expenses relate generally to lodging, meals and tips. A meal allowance generally shall not exceed \$25.00 per day.

Receipts shall be required for lodging expenses and for other expenditures as the Executive Director may deem appropriate and be reported on the travel voucher to show all expenses itemized on a daily basis.

# Background:

STWA provides turnkey management services to Ricardo and Nueces Water Supply Corporations and invoices them monthly. Enclosed are a schedule of the current and proposed FY 2026 General and Administrative Fees and a schedule of the current and proposed fees for Taps and Repairs.

# Analysis:

The most recent analysis indicates in FY 2025 and previous fiscal years that STWA did not recoup the anticipated revenues to cover actual expenses. As such, staff has proposed to adjust fees accordingly. Fee adjustments are necessary to stay in line or track with the cost of providing the services and the amount of time staff is devoting to the Corporations.

# Staff Recommendation:

Staff estimates that these recommended increases in fees and rates are necessary to cover the costs to operate and manage the corporations. Staff examined salaries, benefits, vehicle/equipment repairs, new vehicles/equipment purchases and staff time allocations to arrive at the most accurate estimate for such recommended figures. The proposed increases will cover current STWA management costs; however, these fees should be reviewed annually during the budget process.
